PRESENTATION: This webinar discusses the Core Function #8- Crisis Intervention. Crisis Intervention is a process that provides guidelines and specific behavioral procedures to help a person through a crisis situation. A crisis situation can impact a person by making them feel things like their life is unraveling, and requires specific skills to help the person return to a stable emotional and behavioral baseline. As a result of watching this 1-hour webinar you will leave with an understanding of:

- Understand the IC&RC's definition of Crisis Intervention;
- Understand the IC&RC's Global Criteria of Crisis Intervention; and
- Be knowledgeable in three different coping skills to help a client calm down.
